Subject: Infectious Diseases (Amendment) (No. 3) Regulations 2024 (SI 735 of 2024); Health (Provision of Information for Health Examination and Treatment Service) Regulations 2024 (SI 750 of 2024) ("the Act")

A Chara,

It has come to my attention that on the 13th of January 2025. The Chief Medical officer (CMO), Professor Mary Horgan wrote to the current Assistant Secretary of the Department of Education, Clíodhna O'Neill, advising her on Statutory Instrument 735 of 2024 and Statutory Instrument 750 of 2024 in which these regulations would permit the sharing of class lists by schools to the HSE to "enable the administration of immunisation to children in schools" and "for the purpose of carrying out the school health checks programme".

Please be advised that the Acts and Statutes of any Corporate Department requires the Consent of any Living-Man/Woman being a Citizen of the Irish Republic, to gain the force of Law. The Assumption that a school may share the private information of 'Private' Families without their prior express Consent, to another Corporate Department, under the guise of 'Regulations', is groundless and without foundation.

Further Note, that Corporate 'Regulations' do not, nor cannot, supersede the Inalienable Rights of the Family Unit as per The Sovereign Constitution. As Sovereign Citizens of the Jurisdiction of the Republic of Éire, coupled with the knowledge that Notices of Disqualification for both the 1998 Educational Act and the 1947 Health Act were signed, sealed and delivered in September 2023, the Department of Health/TUSLA and the Department of Education holds no Jurisdiction over any living man, woman or child that stands with said Disqualifications as a Citizen of the Irish Republic. For your ease of reference, I have attached the Disqualification for both the 1998 Educational Act and the 1947 Health Act. I have also attached a recent letter of notice from the Secretary of Education & Irish for Dáil Éireann, Barra S. de Róiste to the current Corporate Secretary General of the Department of Education, living woman, Bernie McNally re: same issue.

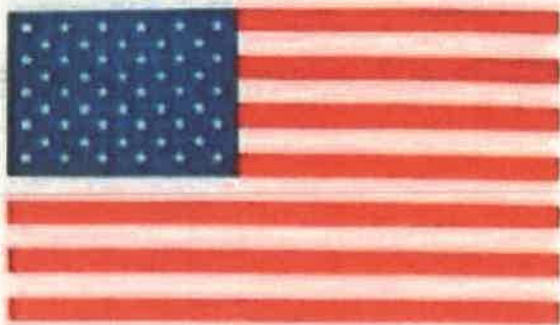

Bernie, a Chara,

I write to advise that the Department of Education & Irish (the "DEI"), together with the Council of Education (the "CE"), have considered the above referenced Act.

It is noted that Professor Mary Horgan (CMO), in her letter of 13th January 2025 to your Assistant, Cliodhna O'Neill, states that the Regulations, "*will permit the sharing of class lists by schools to the HSE to enable the administration of immunisation to children in schools*" and "*for the purpose of carrying out the school health checks programme.*"

As you are aware, any Statutes or Legislation, proposed by any Corporate Department, requires the consent of the Living-Man/Woman for it to hold any power or effect. Any Living Man/Woman, as a Citizen of the Irish Republic, is of course entitled to, if they so wish, to give their express consent to any Statute or Legislation. Any sharing of information under assumptions of implied consent or otherwise, absent the actual express consent of the Living Man/Woman, as Mother/Father of their Son(s) or Daughter(s) is repugnant to the provisions and protections of the Constitution of the Republic of Ireland. **Please Note.**
