EXECUTIVE ORDER

22-8-22

WHEREAS BY the Organisation of the Irish Republican Brotherhood (IRB) the Irish Republic is Proclaimed as a Sovereign Independent State and the right of the People of Ireland to the ownership of Ireland and to the unfettered control of Irish destinies, to be sovereign and indefeasible, is declared and signed by the Supreme Council of the IRB on behalf of the Provisional Government of the Irish Republic on 24th April 1916;

AND by the consequential Country General Election of 28th December 1918 resulting in victory for IRB Sinn Féin with Dáil Éireann and the Dáil Éireann Courts established by the Will of the People of Ireland, and the Declaration of Independence and the Sovereign Constitution being enshrined in International Law on 21st January 1919;

AND by the 1919 Amendment to the Foregoing Constitution of the Irish Republican Brotherhood the powers of the IRB as the Government of the Country being transferred to the Dáil on condition that the Dáil carried out the programme of the Brotherhood to the full letter of the law, and, in case of the Dáil not doing so, the Dáil would automatically cease to be the government of the Country, the functions of which would again revert to the IRB;

AND by the 1920 Amendment to the Foregoing Constitution of the IRB the Supreme Council of the Irish Republican Brotherhood being declared in fact, as well as by right, the sole Government of the Irish Republic whereby Its enactments shall be the Laws of the Irish Republic until Ireland achieves absolute National Independence, and a permanent Republican Government be

established, and the authority of the Supreme Council remaining unquestioned by members of the Irish Republican Brotherhood, and the Supreme Council of the Irish Republican Brotherhood having power to levy taxes, rates, loans, to negotiate and ratify treaties with Foreign Powers, and to do all acts necessary for the protection and Governance of the Irish Republic. And the President of the Irish Republican Brotherhood in fact, as well as by right, to be President of the Irish Republic and he to direct the working of the Irish Republican Brotherhood subject to the control of the Supreme Council or Executive thereof.

AND by the Supreme Council of the IRB being restored by the direction of the President of the IRB on 22nd February 2022 and by the 2022 Amendment to the Foregoing Constitution of the IRB, the authority of the Supreme Council remaining unquestioned by those who have become or who may hereafter become members of the IRB by the mode of initiation, and whereby the IRB Supreme Council retaining all of its rights and responsibilities in relation to the Governance of the Sovereign Republic of Éire, and the Supreme Council continuing to reserve to itself the right of treating with all Nations, Powers and Institutions, on all matters concerning the welfare of Irelands Territory, in the advancement of the cause of Irish Independence and all members continuing to recognise the President of the IRB as the natural and rightful President of the Sovereign Republic of Éire as stated and enshrined and upheld in previous Constitutions of the Irish Republican Brotherhood.

AND by the President and the Supreme Council being satisfied that Dáil Eireann and the Dáil Éireann Courts be not adhering to the programme of the Brotherhood to the full letter of the law, and there being no claim as to any Agreement of Great Britain and Ireland in existence after 5th December 2021, the President and the Executive of the Supreme Council declare under this Instrument that the Dáil be automatically ceased to be the Government of the Country and the functions of which revert to the IRB.

AND so that there be continuance of Lawful Governance of the Irish Republic, the President and the Supreme Council of the IRB hereby determine under the powers of this Instrument that the Supreme Council automatically assume the mantle of the Ministry of Dáil Éireann contemporaneously with the cessation of that body.

AND by the functions of Dáil Éireann being lawfully restored by reversion of their powers to the IRB Supreme Council, and so as to provide for the function of the Dáil Éireann Courts in tandem with Dáil Éireann, in fidelity with the Sovereign Constitution of January 21st 1919 and the Constitution of Dáil Éireann of April 1st 1919 as amended, the President and the Supreme Council hereby elect on consensus Professor Josephine Dolores Cahill to the position of Chief Justice of the Dáil Éireann Courts.

WHEREBY Dáil Éireann and the Dáil Éireann Courts of the Irish Republic will now function in the following manner:

Subject: Sovereign Dáil Éireann by the Will and Wish of the People of Ireland from January 21st 1919

A Chara,

As you are aware, Dáil Éireann for the 32 Counties and Sovereign Territory of Éire was established by the Will and Wish of the People of Ireland on 21st January 1919 following the conditional transfer of Powers from the President of the IRB as sanctioned by the IRB Supreme Council.

That Transfer was reversed by IRB Executive Order 22-8-22 and further positioned by IRB Executive Order 4291, with Secretarial Duties for the Ministry of Dáil Éireann being delineated under the IRB Constitution.
